APPLICATION MUST BE SUBMITTED 10 BUSINESS DAYS PRIOR TO THE NEXT GENERAL MEMBERSHIP MEETING, PLEASE CALL THE OFFICE OR CHECK OUR WEBSITE TO CONFIRM THE DATE OF THE NEXT MEETING.

MEMBERSHIP REQUIREMENTS

Specific requirements for Motion Picture departments:

Any applicant seeking Membership in the Local must first complete a probationary period of 60 days (equivalent of 480 hrs) within the Department of application. These days are to be accrued as an I.A.T.S.E. Local 212 permittee. Maximum requirement of working three feature films and/or made for TV movie and/or episodic television series which are covered by a duly signed Local 212 Collective Agreement. The applicant must, at maximum, work under three different IATSE Local 212 Department Heads and obtain favourable evaluations. Consideration on the number of different IATSE Local 212 Department Heads' may be given, if less than three exist. You must supply copies of evaluation forms completed by the appropriate IATSE Local 212 Department Heads. You are responsible for your evaluations.

Specific requirements for Caucus 3: General Stage:

Any applicant seeking Membership in the Local must first complete a minimum of 480 hours of union stage work, under an I.A.T.S.E. Local 212 work permit, within the classifications of work covered by an I.A.T.S.E. Local 212 Stage Collective Agreement.

Caucus 3: ATP/TC/TJ requirements: Must have a minimum 480 hours worked from all Theatre Companies, may include up to 240 hours from Caucus 2:General Stage venues.

Apply for membership formally using this Membership Application Package. Submit your completed application to the I.A.T.S.E. Local 212 Office only after having the following:

1. Completed a probationary period of 60 days (equivalent of 480 hrs), as per above criteria.
2. Have an up-to-date resume at the Union Office.
3. Copies of evaluations from IATSE Local 212 Department Heads.

Once you have submitted your application package, the Committee along with the Department will review your application and confirm all criteria have been met. You will be contacted should they have any questions. Once criteria has been satisfied and the Membership Committee along with the Department agree all relevant paperwork is complete, your name will be introduced at the General Membership Meeting thereafter. The Membership Application Review Committee will report to the General Membership all relevant activities related to Membership. Your name will then be published in order to introduce you to the General Membership of I.A.T.S.E. Local 212. At the General Membership Meeting following your introduction, the status of your application will be voted on by the Members present at that meeting. The members will vote for acceptance or rejection. You will then be informed of the decision made by the General Membership shortly thereafter.
